The executive branch is led by the president, who is the commander in chief of the military and responsible for signing or vetoing laws presented to them by Congress. The executive branch also includes the vice president, who is the president of the Senate and will take over if the president cannot perform his duties, as well as the Cabinet, who are advisors to the president.

The executive branch can declare Executive Orders, which are like proclamations that carry the force of law, but the judicial branch can declare those acts unconstitutional. The judicial branch interprets laws, but the President nominates Supreme Court justices, court of appeals judges, and district court judges who make the evaluations.

### Checks and Balances - Ben's Guide To the U.S. Government

The Articles of Confederation were adopted by the Second Continental Congress on November 15, 1777, but did not become effective until March 1, 1781, when they were finally approved by all 13 states. Under the Articles, the national government consisted of a unicameral (one-house) legislature (often called the Confederation Congress); there was no national executive or judiciary.
