IMPORT OF HAZARDOUS CHEMICALS ("PRIOR INFORMED CONSENT") Since 1 February 2020, the United Kingdom has withdrawn from the European Union and has become a "third country".¹ 2The Withdrawal Agreement provides for a transition period ending on 31 December 2020. Until that date, EU law in its entirety applies to and in the United Kingdom.³

The Basel Convention sets out a detailed Prior Informed Consent (PIC) procedure with strict requirements for transboundary movements of hazardous wastes and other wastes. The procedure forms the heart of the Basel Convention control system and is based on four key stages (1) notification; (2) consent and issuance of movement document; (3) transboundary movement; and (4) confirmation of disposal.
